

Animal Sale Permit Scheme - Report to Minister for Agriculture

Section 58R of the *Domestic Animals Act 1994* requires the holder of the animal sale permit to submit a report, which complies with section 58R(2) of the Act, to the Minister for Agriculture no later than 28 days after the day of the sale specified in the permit.

Note: Section 58R(3) requires the Minister to provide a copy of the report to the relevant council as soon as practicable.
