- 2. The application fee is **200 fee units** (**\$3,266** as at 1 July 2024) for both new applications (valid for 1 year) and for renewals (valid for 3 years).
 - **EFT Payment:** Payment notice with details for payment will be provided via email upon receipt of application. Please ensure payment deadline stated in payment notice is met.
- **3.** Animal Welfare Victoria will review your application and when assessed as complete may contact you to discuss the assessment process and to offer a site visit to discuss compliance requirements with the Code of Practice for the Operation of Breeding and Rearing Businesses 2014 (June 2018 version).
- **4.** Departmental authorised officers may then inspect the business. This inspection will be undertaken in the presence of the proprietor and will be scheduled to meet appropriate timelines.
- **5.** Victoria's Chief Veterinary Officer will consider the application and information gathered and make a recommendation to the Minister for Agriculture.
- **6.** In most cases, a response will be provided within 60 days of the acknowledgement of receipt of a complete application.
- 7. If approved, requirements for ongoing compliance include:
 - submission of an annual reports
 - allowing Departmental authorised officers to inspect premises during renewal and transfer
 - ensuring no more than the approved number of relevant fertile female dogs are kept on the premises
 - maintaining public liability insurance of \$10 million
 - ensuring appropriate qualifications are held by all staff
 - full compliance with the Code of Practice for the Operation of Breeding and Rearing Businesses 2014 (June 2018 version).
